Letter sent to President Jair Bolsonaro about the farce Covid

[We bring to our readers this important international declaration by health professionals, doctors and scientists, which has been <u>sent to governments in thirty countries</u>. Below is the full text sent to governments. The text includes quotes from prominent scholars and health professionals.]

Urgent: international alert message about COVID-19

February 2021

Mr. Jair Bolsonaro: President of Brazil, Mr. Hamilton Mourão: Vice President and Mr. Eduardo Pazuello: Minister of Health of Brazil,

We are health professionals from the international collective: United Health Professionals, composed of more than 1,500 members (including medical professors, intensive care physicians and specialists in infectious diseases) from different countries in Europe, Africa, America, Asia and Oceania and, on 26 August 2020, we addressed a warning message to the governments and citizens of countries around the world about the outbreak of COVID.

First, let us start with the conclusions of the Council of Europe Parliamentary Assembly's 2010 report on the management of the H1N1 epidemic:

"The Parliamentary Assembly is concerned with how the H1N1 flu pandemic has been treated, not only by the World Health Organization (WHO) but also by the competent health authorities at European Union and national level. Is particularly concerned about some of the consequences of the decisions taken and advice given that lead to the distortion of public health service priorities across Europe, wasted large sums of public money and also unjustified panic and fear about health risks ... Serious deficiencies were identified in relation to the transparency of pandemic-related decision-making processes, which raised concerns about the possible influence of the pharmaceutical industry in some of the main decisions ... unregulated or secret lobbying can be a danger and can undermine democratic and good governance ".

Know that the same mistakes made in the H1N1 epidemic are being repeated today in the COVID epidemic. You are the victims of the greatest health scam of the 21st century with regard to the real danger of the virus, the measures to be taken, the numbers, tests and treatments, and this was done with the same manipulation techniques used during the epidemic the H1N1 or the Iraq war. Experts, medical professors, as well as scientific and medical groups started warning others about this as early as March 2020.

The countries of the world (except for rare cases such as Sweden, Belarus or Tanzania), without thinking, just imitated and blindly followed others.

This epidemic is amplified, dramatized and instrumentalized by criminals who take advantage of it to achieve economic, political and ideological goals and agendas that are harmful to humanity and we will prove it to you. You must stop this global scam quickly (because it is a serious danger to your people and your country in terms of: health, economy, education, ecology and human rights) by immediately taking the following actions:

1 Remove all restrictions

Remove the following illegal, unscientific and non-sanitary measures: quarantine, lockdown, mandatory masks for healthy subjects, social distance of one or two meters. These crazy and stupid measures are heresies invented in 2020 that do not exist in medicine or public health and are not based on any scientific evidence.

This is not how we manage an outbreak:

"The world has gone mad" with coronavirus quarantines that "go against what is known about the treatment of virus pandemics" (Dr. Anders Tegnell, Sweden's chief epidemiologist, 24 June 2020).

« The infection fatality rate seems to be about <u>the same as for influenza</u>, but we have never introduced these drastic measures before, when we had influenza pandemics. And we cannot live with them for years to come.» (Prof. Peter <mark>Gøtzsche</mark>, December 1, 2020).

"The quarantine decision as a decision to use masks ... is not based on scientific data ..." (Prof. Didier Raoult, 24 June 2020).

«The natural history of the virus [the coronavirus] is not influenced by social measures [quarantine, masks, restaurant closings, curfews, etc.] ... The quarantine did not trigger the reduction of cases ... As for the closing of restaurants that had very strict health protocols ... of course, I cannot defend myself ... it did not influence the epidemic at all ... The quarantine has not changed anything ... » (Prof. Philippe Parola, December 3, 2020).

«There is no scientific evidence to support the disastrous rule of two meters. Poor quality research is being used to justify a policy with huge consequences for all of us » (Professors Carl Heneghan and Tom Jefferson, June 19, 2020).

"Grotesque, absurd and very dangerous measures ... a terrible impact on the world economy ... self-destruction and collective suicide ..." (Prof. Sucharit Bhakdi, March 2020. He also sent, at the time, a letter to German Chancellor Angela Merkel)

In addition, these tyrannical measures violate the Universal Declaration of Human Rights in its articles: 3, 5, 9, 12, 13, 17, 18, 20, 26, 27, 28, 30 and the UNICEF Convention on the Rights of the Child in its articles: 28, 29, 32, 37.

«When the state knows best and violates human rights, <u>we are on a dangerous course</u>. The pandemic has led to the violation of basic human rights ... There has not been the slightest ethical analysis of whether this was justified." (Prof. Peter <mark>Gøtzsche</mark>, December 4, 2020).

Forcing non-sick people to wear masks is not only heresy, it is also harmful to health and ecology and is a form of abuse:

«Mask dictatorship totally unfounded» (Prof. Christian Perronne, 22 September 2020).

«The curfew ... was used during the German occupation when the militia and Gestapo invaded the houses. And now we will have the police visiting to see if there are more than six people at the table! What is this madness?!» (Prof. Christian Perronne, October 15, 2020).

«Every winter in Paris, the ICU beds are completely saturated. We transfer patients ... every winter, under normal circumstances.» (Prof. Bruno Mégarbane, anesthesiologist and intensive care physician, September 27, 2020).

«<u>In none of the 2 waves</u> ... were all ICUs saturated, it is false!» (Prof. Michaël Peyromaure, January 18, 2021).

2 Liberate the economy, schools, universities, air transport and hospitals

3 Remove your experts and consultants who have links or conflicts of interest with pharmaceutical companies

The 2010 report by the Parliamentary Assembly of the Council of Europe on the management of the H1N1 epidemic also said:

"The Assembly calls on public health authorities at international, European and national level - namely the WHO - ... to ensure that all people subject to conflicts of interest are excluded from sensitive decision-making processes."

Experts in the countries that have defended these totally heretical measures are ignorant or supported or corrupted by the pharmaceutical industry.

4 Demand an international and independent investigation and that those responsible for this coup are tried

On October 1, 2020, German lawyer Reiner Fuellmich announced that an international network of lawyers will discuss the biggest civil liability case of all time:

"Anti-corona measures have caused and continue to cause such devastating damage to the health and economy of the world population that the crimes committed by (...) WHO should be legally qualified as real crimes against humanity, as defined in section 7 of the crime code International".

He also said that this should be called "a corona scandal and those responsible for it should be prosecuted criminally and prosecuted for civil damages". The investigation should focus, among others, on Bruce Aylward (WHO) and Neil Ferguson (ICL).

On January 10, 2021: a letter relayed by The Sun and written by lawyers, a member of Parliament, human rights activists and a former US Air Force general was addressed to the FBI and MI5, along with security services in Canada, Germany and Australia, where the authors say:

"We are writing this letter to request that a federal investigation be initiated and / or accelerated in relation to the scientific debate on major political decisions during the COVID-19 crisis. In the course of our work, we have identified issues of a potentially criminal nature and we believe that this investigation is necessary to ensure that the interests of the public have been properly represented by those who promote certain pandemic policies ».

<u>The letter</u> calls the quarantine "a global scientific fraud of unprecedented proportions" that was "deliberately enacted ... to impoverish the nations that implemented it."

Rare countries like Sweden, Tanzania or Belarus - which can be congratulated - refused quarantine and did not blindly follow others and if we apply the reasoning of quarantine advocates, the result should be a massacre or the saturation of their hospital system. Is this the case in these three countries?

The answer is, of course, no. In addition, on September 15, 2020, the BMJ published an article entitled:

«COVID-19: How does Belarus have <u>one of the lowest death rates</u> in Europe?».

These three countries are living proof of the quarantine coup and as this reality can awaken public opinion and people realize that they lied to them, a corrupt press has spread, from the beginning, articles and even fake news, against Sweden and Belarus.

The famous international slogan:

"Stay home, save lives" was a pure lie. On the contrary, quarantine has not only killed many people, it has also destroyed physical and mental health, the economy, education and other aspects of life. For example, quarantine in the USA killed thousands of Alzheimer's patients who also died far from their families. In the UK: the quarantine killed 21,000 people.

The effects of the quarantine «were absolutely harmful. They did not save the lives they had announced that they could save ... It is a weapon of mass destruction and we see its health ... social ... economic effects ... that form the real second wave " (Prof. Jean-François Toussaint, September 24, 2020). Arresting your people is a crime against humanity that not even the Nazis committed!

<mark>Gøtzsche</mark>: This is blatantly false. The Nazis arrested and murdered their own people, e.g. 200,000 people with disabilities.

«This country is making a dramatic mistake ... What are we going to suggest? Will everyone be locked up for a lifetime because there are viruses out there?! You're all crazy, you're crazy! ... We are setting fire to the planet " (Prof. Didier Raoult, 27 October 2020).

"It is a great delusion, but it is instrumentalized by large pharmaceutical industries and also by politicians ... It is an organized fear for political and economic reasons" (Prof. Christian Perronne, 31 August 2020).

"It is just a global coup to make big profits, rescue the banks and, meanwhile, ruin the middle classes in the name of an epidemic ... made destructive by libertarian measures, allegedly sanitary" (Dr. Nicole Delépine, December 18, 2020).

Gøtzsche: Conspiracy theories are not helpful.

"We have medical evidence that this is a scam" (Dr Heiko Schöning, July 2020).

Gøtzsche: What exactly is claimed to be a scam? The two million deaths so far are real.

«Think about these two questions: ... Is the coronavirus artificial? ... Did they try to use this viral disease or this psychosis for their own purposes and interests?» (Alexander Lukashenko, President of Belarus).

Gøtzsche: This is a horrible quote. It has been documented by analysing genomes that the coronavirus was not produced in a Chinese laboratory in Wuhan but likely came from a bat.

"There is a totally unfounded public hysteria driven by the media and politicians. It's outrageous. This is the biggest hoax ever perpetrated against an unsuspecting public ... it should be known as nothing more than a season of strong flu. This is not Ebola. It is not SARS "(Dr. Roger Hodkinson, November 13, 2020).

Gøtzsche: What exactly is claimed to be a hoax? The two million deaths so far are real.

5 Do not blindly follow WHO recommendations and demand that it be completely reformed

An investigation carried out in 2016 (WHO in the grip of lobbyists) showed an edifying X-ray of WHO; a weakened structure subject to multiple conflicts of interest. This investigation showed how private interests dominate public health at WHO. Another investigation (Trust WHO) also revealed these serious anomalies.

6 Use recognized measures for the management of epidemics

Such as recommendations for hand washing, sneezing or coughing in the elbow, wearing a mask, but only for patients and health professionals (in specific situations), isolating patients, etc. The severity of an epidemic is assessed by the case fatality rate (CFR), among other things. However, it is very low (0.13-0.15%) and, therefore, there is no justification for taking measures that, in addition to being disproportionate, are also not scientific.

7 Make the media aware of their responsibilities

The media should, for example, stop talking about the coronavirus.

Gøtzsche: This could be interpreted as censorship, which we should avoid at all costs. The media have not lived up to their responsibilities, as they have mainly been mouthpieces for our governments, and they virtually never comment on the opportunity costs, the many lives lost due to our lockdowns and the huge damage to our national economies.

8 Remove the testing requirement

People pushing for mandatory testing are defrauding governments and pursuing only economic goals. Nothing about this coronavirus (which is a benign low-CFR virus) justifies it. The flu infects one billion people each year, far more than SARS-CoV-2, spreads faster and has more populations at risk than this coronavirus, yet no test is needed to travel. That is why Professor Didier Raoult called the statement that it is a serious illness "delirious" and said, on August 19, 2020, that "it is no worse than the flu".

<mark>Gøtzsche</mark>: Most of this is false. Some people who push for testing do so for humanitarian reasons. It has not been documented that influenza is more contagious than corona, and *fewer* people are at serious risk for influenza than for corona because there is some immunity in the populations against influenza.

"The infection mortality rate for this new coronavirus is likely to be on the same level as seasonal influenza" (Prof. John Ioannidis, 17 April 2020).

"Reassure the vast majority of the population that the risk of dying or contracting serious COVID-19 disease is very low" (Prof. John Ioannidis, 22 April 2020).

"Be aware? Today, we are destroying the economy and, finally, the numbers are comparable to those we have experienced with the flu!» (Prof. Christian Perronne, October 25, 2020).

9 End the vaccination campaigns and refuse the fraud of the pseudo-sanitary passport, which in reality is a political-commercial project

"We don't need it [the vaccine] at all ... All of this has to do with purely commercial objectives" (Prof. Christian Perronne, 16 June 2020).

Gøtzsche: This statement is appallingly false. We desperately needed good vaccines, and they seem to have lowered hospital admissions and deaths dramatically already.

«It is an old marketing principle of pharmaceutical companies: if they want to sell their product well, the consumer must be afraid and see it as their rescue. So, we created a psychosis for consumers to collapse and rush into the vaccine in question." (Prof. Peter Schönhöfer).

Gøtzsche: Two million deaths and dramatic effects of the vaccines can hardly be called a psychosis.

«As a doctor, I have no hesitation in anticipating government decisions; we must not only refuse these vaccines [against COVID-19], but also denounce and condemn the purely commercial approach and the abject cynicism that guided its production.» (Dr. Pierre Cave, 7 August 2020).

Gøtzsche: Having come this far in the document, I have had enough of all the totally false "antivaxxer" statements. I hope people will read my vaccine book, which has a chapter on COVID-19 that I updated in January 2021 for the <u>US print version</u> that comes out on 1 June. The updated chapter is already out in the <u>German translation</u>.

The COVID vaccine is "so, so unnecessary." (Prof. Sucharit Bhakdi, December 2, 2020).

Gøtzsche: This is nonsense to the extreme.

«I have never seen in the history of medicine that we urgently developed vaccines to vaccinate millions, billions of individuals for a virus that no longer kills but at risk people that we can identify, that we can treat ... I have never seen a vaccine coming out after 2 months! ... It takes years! » (Prof. Christian Perronne, December 2, 2020).

Gøtzsche: More extreme nonsense and false information. There is NO effective treatment for the coronavirus. NONE.

«We are going too fast. If there was an emergency ... if today COVID-19 kills 50% of people, I will say we will take a risk ... but here we have a virus that kills 0.05% and we will assume all the risks! I know that there are billions behind it ... Watch out, this is very dangerous» (Prof. Christian Perronne, December 2, 2020).

Gøtzsche: More nonsense.

To the question: "Do we need a general vaccine for all of humanity with 0.05% of deaths?", Professor Christian Perronne replied: "Obviously not! ».

On November 30, 2020: Professor Christian Perronne wrote a letter in which he warned of the danger of vaccines based on genetic engineering: "The people who promote these genetic therapies, falsely called "vaccines", are apprentices of sorcerers and take ... the citizens of the world as guinea pigs".

<mark>Gøtzsche</mark>: Pure nonsense. These vaccines have been shown to lower severe disease drastically. People who are vaccinated are not guinea pigs.

On October 19, 2020, in correspondence with The Lancet, scientists expressed concern and warned: "We are concerned that the use of an Ad5 vector for immunization against severe acute respiratory syndrome (SARS-CoV-2) coronavirus 2 may also increase the risk of acquiring HIV-1 among men who receive the vaccine."

Gøtzsche: The crucial word is "may." COVID-19's deadly consequences are not a "may," they are real.

If people accept the COVID-19 vaccine, it will be: «A mistake because we run the risk of having absolutely unpredictable effects: for example, cancers ... We are playing the total sorcerer's apprentice ... Man should not be a guinea pig, children should not be a guinea pig, it is absolutely unethical. There should be no deaths from vaccines "(Prof. Luc Montagnier, Virologist and Nobel Prize in Medicine, December 17, 2020).

Gøtzsche: It is tragic that Montagnier is so far-off reality in relation to COVID-19. He got the Nobel Prize for discovering the virus that causes AIDS. I have written about this in my <u>book about</u> <u>mammography screening</u>: "John Crewdson from the Chicago Tribune had already contacted me in November 2000 and asked to have a meeting, which became several meetings. Crewdson won the Pulitzer Prize for a series of articles on US immigration injustices and has a reputation for a Columbo style of information gathering where he feigns confusion and keeps asking questions.¹ He also worked on a case where the evidence strongly suggested that the American Robert Gallo had stolen the credit for the detection of the AIDS virus from the Frenchman Luc Montagnier, who sent specimens of his discovery to Gallo; an affair that was settled at presidential level to save faces.² Crewdson reported that Gallo's laboratory was not forthcoming, and that doors closed and the lights went out once the NIH figured out what Crewdson was doing."

In Switzerland, a group of 700 doctors and health professionals called on January 15, 2021 for the vaccination campaign to be stopped.

«I think it is [the COVID vaccine] frankly dangerous. And I warn you, if you follow these lines, you will go to your doom.» (Prof. Sucharit Bhakdi, December 2, 2020).

<mark>Gøtzsche</mark>: Nonsense. Falsehoods do not become true because the same few people are quoted again and again.

On December 30, 2020: Réaction 19 (a French association founded by lawyers with around 60,000 members) reported, in a press release, that it filed a complaint about the "vaccines" Pfizer / BioNTech and Moderna for: deliberately placing the life at risk for others, aggravated deception, abuse of weakness and aggravated extortion.

Recently, several members of the European Parliament have alerted the population because they are prohibited from seeing the contracts signed with pharmaceutical companies. This opacity is proof that there are compromising things that they want to hide. Michèle Rivasi, a member of the European Parliament, came to make a <u>complaint</u>. <u>Remember</u>: In 2009, Pfizer was fined \$ 2.3 billion, the largest fine ever imposed by the United States courts on a pharmaceutical group. Pfizer was found guilty of fraudulent business practices.

In 2010, AstraZeneca was fined 520 million euros for recommending the unauthorized use of a medicine. In 2011, Merck paid a \$ 628.36 million fine for resolving off-label marketing claims and false statements about a drug's cardiovascular safety. In 2013, a fine of 1.62 billion euros was imposed on Johnson & Johnson to resolve criminal and civil liability arising from allegations related to the prescription of three drugs, including the promotion of uses not approved as safe and effective by Food and Drug Administration (FDA) and payment of bribes to doctors and the country's largest pharmacy supplier for long-term care.

We must stop this global coup where the political-economic (even ideological) agendas of criminals are for COVID what the Iraq war was for the September 11, 2001 attacks (here is a reminder of the Iraq war coup: https://youtu.be/miZW_DGjlec). These criminals manipulate the countries of the world and want the epidemic to last as long as possible to achieve their goals when the COVID epidemic should have been declared for a certain time in the past year; in fact, in medicine, the epidemic threshold at which the beginning and end of an epidemic is declared is from 150 to 200 cases per 100,000 inhabitants. The Tanzanian president is one of the few presidents who understood this because he declared on June 8, 2020 that the COVID epidemic was over in his country.

"<u>The epidemic is over</u>!" (Professor Yoram Lass, July 2, 2020).

Gøtzsche: This is certainly NOT the case.

In this epidemic, the danger is not the coronavirus, but the people who use it and who are the real virus to fight.

The virus is completely innocent of what is happening (impoverishment, job losses, suicides, deaths, economic recession, unemployment, etc.) and the real culprits are those who pressured the world to use these measures and the governments that continue to implement them despite warnings and warnings.

Gøtzsche: How can a virus that has caused 2 million deaths be completely innocent of deaths? It is correct that a lot of the misery we have seen has been caused by our governments, which have introduced measures in most countries that were far too drastic. <u>See Ioannidis recent paper</u> about major and minor lockdowns, there was no difference.

"The World Bank has just estimated that the corona pandemic has caused an <u>increase of about</u> <u>100 million people living in extreme poverty</u>. This is not because of COVID-19. It is because of the draconian measures we have introduced." (Prof. Peter <mark>Gøtzsche</mark>, December 1, 2020).

The discrepancy and disproportion between the level of dangerousness of the virus and the magnitude of the measures taken (which, incidentally, are totally heretical) are so evident that they inevitably lead to the conclusion that there are other objectives behind them. You have to be really blind or naive to not see.

Having nothing to do with medicine or science, governments are not fighting against the dangers of the virus, but against the basic rights of their people and destroying their health, economy, education, ecology, culture and other aspects of life.

«Since the beginning we have lived a kind of delusion ... We live in a world that is crazy: ... the conditions that have been required to fight this disease are conditions of another century ... they are not even at the level of the Middle Ages!» (Prof. Didier Raoult, December 7, 2020).

Gøtzsche: Wrong. Quarantine was also used in the Middle Ages, e.g. when plague infested ships came to Italy, and the word quarantine comes from that: "During the 14th century Venice wanted to protect its citizens from plagues that were potentially present on ships. To do so, they required all ships coming from ports that had been infected to anchor off the coast for forty days. The Italian for this quaranta giorni or quarantena saw the coining of the term quarantine."

On December 28, 2020, Randy Hillier, a Canadian doctor, wrote this message on Twitter along with the hashtags: #We are living a lie and #End of quarantines: «Covid's lies and fraud are over. It will take years to discover how and why so many were deceived ».

It is not because most countries are doing the same thing that it means that it is good or that it is the right thing to do. The number is not a criterion as to whether countries are right or not to apply these measures. On the contrary, many historical examples show that most are often wrong; Iraq War (rare countries like France did not follow and were right), H1N1 (rare countries like Poland did not follow and were right), World War II, etc. The conspiracy theory charge is the response of those who have no arguments and a technique of mass manipulation because everything reported in this letter does not consist of theories, but of truths and statements made by eminent experts, including Nobel Prize winners in medicine.

Gøtzsche: There are many falsehoods in this document, and I have spotted only one Nobel Prize winner. Further, being a Nobel Prize winner does not mean that you are automatically right. This we call the trick of persuasion by eminence rather than evidence. Double Nobel Prize winner Linus Pauling was totally wrong with his idea that vitamin C was effective for the common cold: "Vitamin C became particularly popular in the 1970s when Nobel laureate Linus Pauling concluded from placebo-controlled trials that vitamin C would prevent and alleviate the common cold. However, <u>Pauling's book about this is an appalling example of selective citation</u>, of which we might not expect a Nobel laureate to be guilty."

This letter will be kept as proof that your government has been alerted. Everything should return to normal immediately and this global hostage taking must stop because you now know that you have been the victim of the greatest health scam of the 21st century.

Please do not make the mistake of underestimating our letter or ignoring it. Here are 2 examples of what happens when a government makes this mistake:

Despite warnings from several experts about the danger of Dengvaxia (dengue vaccine), the Philippine government decided in 2016 to launch a vaccination campaign that later ended in a public scandal. According to prosecutor Persida Acosta, 500 children died from the vaccine and many thousands are sick.

According to the prosecutor, the responsibilities are shared between the company that sold "a dangerous vaccine" and the government that set up a "massive and indiscriminate" vaccination campaign, under deplorable conditions. This vaccine, however, promised to be a planetary triumph; in 2015, Sanofi confirmed with great fanfare the marketing of a revolutionary vaccine against dengue. It was a world premiere, the result of twenty years of research and 1.5 billion euros of investment.

However, from the beginning, voices were raised in the scientific community: Dr. Antonio Dans tried to warn about the inconclusive results of the first clinical trials. In the USA, Professor Scott Halstead, a world-renowned specialist in the disease, even sent a video aired in the country's Senate to ask for the suspension of the vaccination program. The country's former health minister was accused of this scandal. "It was the bait of profit that killed these children," said prosecutor Persida Acosta.

The second example is the scandal of the H1N1 vaccine that was purchased by several countries despite warnings from Dr. Wolfgang Wodarg, the chairman of the Health Committee of the Parliamentary Assembly of the Council of Europe, who in a recommendation motion entitled "False Pandemics - a health threat" said: "In order to promote their patented flu medicines and vaccines, pharmaceutical companies have influenced scientists and official agencies responsible for public health standards to alarm governments around the world."

They made them waste limited health care resources for inefficient vaccine strategies and unnecessarily exposed millions of healthy people to the risk of unknown side effects from insufficiently tested vaccines. He was right because, later, in Europe alone, the vaccine claimed 1,500 narcolepsy victims including 80% of the children [Gøtzsche, sic: incluindo 80% das crianças; the meaning likely is that 80% of the victims were children] so much so that on 24 November 2013, Swedish Minister of Social Affairs, Göran Hägglund, said he was ready to apologize publicly to the victims of the swine flu vaccine.
